MetaMap's JSON Output

MetaMap JSON output was introduced in MetaMap16V2; previous MetaMap versions do not include this functionality. Basic information about JSON syntax is available [here](#); more detailed information about JSON is available [here](#).

1 Structure of MetaMap's JSON Output

A high-level representation of MetaMap's JSON output for an input file containing three input records or documents is the following:

```
{ "AllDocuments": [

2 Generating MetaMap's JSON Output

To generate JSON output, simply call MetaMap with one of these two options:

- `--JSONn`, to generate unformatted JSON output, which contains no formatting whitespace. This form of JSON output is not easily human readable, but creates output files about 40% of the size of MetaMap's formatted JSON, described next.
- `--JSONf N`, to generate formatted JSON output, where N is a (preferably small) non-negative integer determining the number of spaces in each incremental indentation. This form of JSON output is human readable, but creates output files over twice as large (assuming `--JSONf 2`) as MetaMap's unformatted JSON.

The calls to `metamap.JSON` should be of the form

```
metamap.JSON --JSONn -E [other MetaMap options]
```

or

```
metamap.JSON --JSONf 2 -E [other MetaMap options]
```

See Appendices A and B at the end of this document for examples of both formatted and unformatted JSON output.

3 Internal Structure of MetaMap JSON Output

MetaMap's JSON output is very similar to MetaMap's XML output, which is described [here](#), and uses many of the same tags. Appendix C below explains the structure of MetaMap's JSON output in great detail.

Appendix A: Formatted MetaMap JSON output

The following is the formatted JSON output generated from the input text `no heart attack` (HA) using the command-line option `--JSONf 2`. The line numbers are referred to in Appendix C; they are included in this document for illustrative purposes only—they are not part of MetaMap's JSON output.

Appendix B: Unformatted MetaMap JSON output

The following is the unformatted JSON output generated from the same input text (`no heart attack (HA)`) using the command-line option `--JSONn`. The actual output file contains only one line, but line breaks have been inserted here for display purposes.

Appendix C: Structure of MetaMap’s JSON output

1 Top-Level

As noted at the beginning of this document, a high-level representation of MetaMap’s JSON output for an input file containing three input records or documents is the following:

We now explain the internal structure of a `Document: { ... }` JSON pair. In the remainder of this Appendix, line numbers refer to those shown in Appendix A above.

2 The Document Object

The `Document` JSON object contains four pairs:

2.1 The CmdLine Pair

The `CmdLine` pair spans lines 5–27 in Appendix A and represents the command line used to invoke MetaMap. It contains two pairs:

"Command": { command-line call },
"Options": [ command-line options ]
```

The `command-line call` is the text that was used to invoke MetaMap, e.g.,

```
metamap.JSON -L 2015 -Z 2015AB --JSONf 2
```

The `command-line options` are rendered as JSON objects such as

The three command-line options above include both a name and a value; options requiring no value, such as `--ignore_word_order (-i)` or `--all_derivational_variants (-D)` appear as simply

2.2 The AAs Pair

The AAs pair spans lines 28–38 in Appendix A, and represents the acronyms and abbreviations that MetaMap detected in the text. The only acronym in the text is HA, whose expansion is **heart attack**; the data describing this AA are rendered in JSON as

2.3 The Negations Pair

The Negations pair spans lines 39–58 in Appendix A, and represents the negations that MetaMap detected in the text. MetaMap's negation detection is based on Wendy Chapman's [NegEx](#), and includes some significant extensions, documented [here](#).

The only negated concept in the text is **heart attack**, which is negated by the trigger **no**; the data describing this AA are rendered in JSON as

2.4 The Utterances Pair

The **Utterances** pair spans lines 59 through the end of Appendix A, and contains all data generated for the utterances in the input text. Each JSON object representing an utterance has the following form:

2.4.1 The Phrases Pair

The **Phrases** pair spans lines 67 through the end of Appendix A, and contains all data generated for the phrases comprising the enclosing utterance. Each JSON object representing a phrase has the following form:

Note that the value of the **Candidates** pair will be [] unless the `--show_candidates (-c)` command-line option is used, in which case the candidates will be rendered as shown below in the **MappingCandidates** JSON pair described below in Section ??.

2.4.1.1 The SyntaxUnits Pair The **Phrases** pair spans lines 70–84, and contains data representing the syntactic parse of the phrase. Each JSON object representing a syntactic unit has the following form:

2.4.1.2 The Mappings Pair The **Mappings** pair spans lines 88 through the end of Appendix A, and contains all data representing the UMLS concepts identified by MetaMap that appear in MetaMap's final mappings. This pair contains the data probably of greatest use and interest. Each JSON object representing a mapping has the following form:
